Notify you as under: -

- 1) That you are franchisee of above-named company by agreement executed between you and our company on **dated 23/10/2023** You are agreed to perform all terms and conditions as specified in the said agreement and the therefore bound by the same.
- 2) As per term said of agreement, you agreed to do admission of at least **30** students in year. So, by this notice, our company notify that you have to Deposit renewal fee of 12000/- and GST is Applicable within 7 days from the day of receipt of this notice. ...

Otherwise, your franchisee ship agreement will be termed to be terminated and cancelled. In such case, company may appoint new franchisee in your area.

Even after such termination, as per said of agreement, you are still bound by following terms of agreement.

- ii) You should not do any business of education relating to abacus and Vedic maths individually or with any other institute or organization for period 5 years from the date of termination of previous agreement.
- iii) You Should not directly or indirectly contest or aid in contest the validity or ownership of proprietary and copyrights in study material and books of our company.
- iv) You should not copy, reproduce, duplicate any or in whole any books, study material or abacus kit in any manner.

If you do not obey above mentioned terms and conditions, you will be liable to compensate our company for Rs. 1,50,000 /- (Rupees One Lack Fifty Thousand only) And legal action may be taken by us.

So, in terms of above our company terminates your franchisee rights and authority in said agreement.

If you wish to renew and continue agreement you can apply for renewal within 7 days (before 14 October, 2024) with renewal fee. Take note that, to renew or not to renew agreement is pure discretion of our company.
